- e. Village Design Statement Circular being distributed mid September. Return date for the survey will be mid October. Exhibitions to take place in November.
- f. Potholes, Road Signs, and Drain covers. A Scheme Request Form will be returned to the Highways Department following the next Parish Council Meeting. Councillor Moran requested priorities for the Highways Panel at the October meeting. Councillor Moran also explained that the white paint that has recently appeared on our local roads is no guarantee that any resurfacing work will be undertaken within the near future, or indeed if at all. At this stage they are just surveying marks.
- g. Elmdon Dial The Elmdon Community Group has a meeting planned for the 7th September with the new Owner and anticipate an update of the situation at that time.
- h. Local Plan A letter on behalf of the Parish has been sent to Uttlesford District Council. Councillor Moran noted that Essex County Council has commented on the Local Plan. The Council thanked Penelope Gaine for her personal explanation and comments on the Local Plan in the Gazette.

i. Defibrillators – A fund raising team would now be required to raise the necessary funding for 2 defibrillators. This is in hand.
